
OARC Applies to Standing Hearing for The Public Inquiry into the Safety and Security of Residents in the Long-Term Care Homes System

OARC has applied to attend the LTCH Public Inquiry Standing Hearings being held on December 12th and 13th.

The Long-Term Care Homes Public Inquiry was called by Ontario's Premier following Elizabeth Wettlaufer's conviction that included eight counts of first degree murder, four counts of attempted murder and two counts of aggravated assault; offences she committed while working as a registered nurse in Long-Term Care Homes.

"The Inquiry's mandate is to inquire into the events which led to the offences committed by Elizabeth Wettlaufer. Additionally, the Inquiry is directed to inquire into the circumstances and contributing factors allowing these events to occur, including the effect, if any, of relevant policies, procedures, practices and accountability and oversight mechanisms. The Inquiry is also directed to inquire into other relevant matters that the Commissioner considers necessary to avoid similar tragedies." The Ministry of Health and Long-Term Care's Long-Term Care Inspection Branch has re-organized the Inspection Program model. Some of the key activities that have been undertaken are adding management roles to enhance leadership; adding centralized program support functions for consistency; and, creating two additional Service Area Offices (Oshawa and Waterloo area).
