#### **OARC Resident Leaders in Action!**



## **CLRI Dementia Care Preparedness Initiative Launches + Alzheimer's Month**

Last week, OARC shared some exciting news about the launch of a new Dementia Care Preparedness Initiative, which you can read about in <u>this bulletin</u>. We hope that long-term care home teams are starting to discuss and explore this opportunity!

This announcement coincides with <u>Alzheimer's Awareness Month</u>, which is recognized Canada-wide in the month of January. This is a time where we can work together to raise awareness and take steps to deepen our understanding of what people living with dementia experience, day to day.

In Ontario long-term care homes, we know that many residents are living with cognitive changes, including a diagnosis of dementia. OARC often hears from Residents' Councils seeking resources to support their understanding and strategies to make their meetings as inclusive of possible. As January draws to a close, OARC encourages Councils to consider how they might work together to capture perspectives of ALL resident peers, including those who might not attend meetings, and those that might not be able to speak for themselves.
