July 30th is the International Day of Friendship!

CSA Group Releases New Mental Health and Well-Being Standard

On July 23rd, the Canadian Standards Association (CSA) Group released a <u>National Standard</u> of Canada for mental health and well-being in long-term care and assisted living settings (*CSA* <u>Z2004</u>). This standard provides guidance for long-term care and assisted living home Administrators and team members on how to promote good mental well-being for residents.

According to Dr. Julia Kirkham, a geriatric psychiatrist and researcher who led the subcommittee involved in developing the standard, "CSA Z2004 sets a new benchmark for community care by integrating principles that enhance the quality of life and mental health for all residents, regardless of whether they have a mental health condition. It represents a significant step towards long-term care and assisted living settings that support the whole person, including their physical and mental health and well-being" (CSA, 2024).

OARC Resident Leaders were pleased to be amongst the targeted groups consulted last fall to inform the standard. Residents brought forward their ideas and lived experience, and a shared passion for the topic at hand. While national standards remain voluntary, residents agreed that there is a critical need to prioritize mental well-being in long-term care. Reinforcing this message, Gale Ramsden, OARC Resident Advisor and Board Director recently shared, "long-term care is the right choice for many people medically... but we need to catch up to satisfy the needs of the whole person."

The critical connection between mental well-being and social relationships is emphasized through one of the key recommendations in the standard which speaks to the need for team members to be adequately resourced and supported to develop meaningful relationships with residents, their family members and other care partners.

Quality Corner – OARC Research Project Update

On behalf of the research team, we would like to thank everyone who has reached out with interest to participate in interviews as part of our <u>"Empowering Ontario Long-Term Care Residents to Shape the Places They Call Home"</u> project. We had a great response from residents, team members and Administrators, which has been very encouraging!

With most interviews now completed, we will be starting to review and analyze what we've heard through these informative conversations, and using this data to guide the next phase of our project in the coming months.

While interviews have been in full swing, OARC's summer Practicum student, Molly Hutchinson, has been busy working with Resident Leaders on our research team to draft a detailed report, capturing the key findings and themes that emerged from a thorough review of existing research about resident engagement in home operations and

decision-making. This 'scoping review' is currently undergoing a series of revisions before being submitted for publication in the Canadian Journal for Aging.

Our team looks forward to sharing highlights from our research process and outcomes to date with sector partners and the research community this fall, including a <u>webinar hosted by the AWARD Network</u> (September 4th), and at an in-person session at <u>the Ontario Long-Term Care Association (OLTCA) This is Long Term Care conference</u> (October 20-22). We hope you can join us!

Updates from Our Ministry of Long-Term Care

July 19, 2024: Premier Ford Announces Updated Parliamentary Assistant Roles
On July 19th, Ontario Premier Doug Ford announced <u>changes to the government's</u>
<u>parliamentary assistants</u>. Of note to our sector, MPP Kevin Holland (Thunder BayAtikokan) has been appointed the new Parliamentary Assistant to the Minister of LongTerm Care. Read MPP Holland's full biography <u>here</u>.

July 16, 2024: Hiring More Nurse Practitioners in Long-Term Care

The Ministry released a memo to the sector, outlining the government's commitment to provide up to \$28,411,900 in base funding for the Hiring Nurse Practitioners in Long-Term Care (HMNP for LTC) initiative for the 2025-26 fiscal year.

First announced in October 2022, this program has provided funding over the last 3 years for LTC homes to hire and retain up to 225 additional nurse practitioners.

Anticipated Long-Term Care Home Closures

In recent months, OARC has learned of the anticipated closure of several long-term care homes in Ontario. LTC Homes may close for a number of reasons, including the inability to upgrade or rebuild to meet legislated requirements and safety standards.

The OARC team is here to support residents and teams during these uncertain times and periods of transition. We invite those living in homes affected by anticipated closures to reach out and stay connected to us and to consider attending our <u>Forums</u> for peer support. OARC Resident Leaders may have helpful advice to impart to residents preparing to move to another home.

 "Many folks are now stepping up to make suggestions knowing that their suggestions don't fall on deaf ears."


