Last month, OARC welcomed a new Resident Leader, Jennifer Brown, into our Resident Expert Advisors and Leaders (REAL) group. A thoughtful and gifted writer, Jennifer has generously shared the following article capturing her experience living at Lakeside LTC Centre in Toronto, ON.



Giving Thanks! By Jennifer Brown

Until recently, it would never have occurred to me to be writing, let alone sharing, this! But, amidst all the bad news surrounding long-term care, I have experienced some things to be grateful for. These need to be documented. So, here it goes!

My home gave my husband and I a place to be together, in his last months. Knowing that I was in the room next door brought him joy, just as it brought me peace. He died here quietly, contentedly, surrounded by everyone he loved. I am so grateful for that.

I have found work here, that keeps me motivated and engaged. Advocacy that makes full use of skills developed through life.

I have made new friends here. Real friends. One who, like me, lives here, shares some of my advocacy work and, invites me into his home and family. We celebrate small victories here and even enjoy the occasional afternoon at the opera. Another, whose husband died here, has become the closest I'll ever come now to "family." We spend hours each week exploring lakeside parks on our walkers or, in challenging weather, gazing at the water or simply people-watching! Life does tend to slow down with age. I no longer feel the urge to be endlessly "doing." Simply observing is often enough. We celebrate birthdays and special holidays together and talk, endlessly of "life back in the day." These friends are a gift.

My room here is my refuge. A place full of memories provided by the mementos of life lived on several continents. Pictures, hangings, books, music and artifacts that offer echoes of my life, well-lived. A place where I can retreat to the past in peace and contemplate the future with equanimity.

I have found acceptance here. This just might be the greatest gift of all. I am cared for, listened to, and respected. I can be myself. On any day, in any mood, I am accepted.

In this Thanksgiving season, I have realized that this life, the one I really didn't choose, has brought me some very special gifts.

OARC REAL Member Sharing – September 30th Reflections

On September 30th, many residents and team members wore the colour orange to commemorate the fourth National Day for Truth and Reconciliation – also known as Orange Shirt Day. This day was created to recognize the lasting impacts of the residential school system in Canada, and to honour survivors and the children who were taken and never came home.

The origins of the Orange Shirt Day movement can be credited to a woman by the name of Phyllis Webstad, who bravely shared her story about having her orange shirt taken from her when she was forced to attend a residential school in British Columbia. Wearing orange helps us to remember these tragic historical events, and it conveys the powerful message that 'Every Child Matters'.

Resident Leader and OARC REAL
Group member, Steven Wenzowski
(pictured right with team members
from Queens Garden, Hamilton)
shared that he spent much of
Monday engaged in deep
reflection. At his long-term care
home, there was an opportunity to
watch a video about residential
schools which included stories from
survivors describing their
experiences. A display area was set
up in his home's lobby, and an



"Every Child Matters" flag was flown outside. "I always think – what if it was you?" Steven shared. "Mans' inhumanity to their fellow man. Still ongoing today."

Many residents living in long-term care homes have asked OARC how they can start to learn about the Indigenous Peoples of Canada, including their history, traditions, and culture, and support the Truth and Reconciliation Commission of Canada's "Calls to Action". What is most important is that we each start somewhere, and that we respect and meet others wherever they are on their journey of learning and understanding.

October 2, 2024: Seasonal Respiratory Illness Preparedness for LTC Homes 2024-2025
